Code of Conduct for Junior Members

(To be issued to Junior Members upon their being elected to Membership of the Club.)

- 1.0 Young people between Primary School age and 17 years are entitled to apply for Junior Membership of the Club.
- 2.0 Junior Members shall have no vote in the management of the Clubs affairs.
- 3.0 A Member of the Junior Section on reaching the age of eighteen years will be eligible to become a Full Member. Members of the Junior Section will be subject to the whole Constitution, Rules and Bye-Laws of the Club as if they were Full Members.
- 4.0 As a member of Lundin Bowling Club, Junior Members are expected to abide by the general Code of Conduct – Policy No. 3 and this junior code of conduct:
- 5.0 Lundin Bowling Club is fully committed to safeguarding and promoting the well-being of all its members. The club believes that it is important that members, coaches, administrators and parents associated with the club should, at all times, show respect and understanding for the safety and welfare of others. Therefore, parents/guardians are encouraged to be open at all times and to share any concerns or complaints that they may have about any aspect of the club with the Secretary/Child Protection Officer as appropriate.
- 6.0 All members must play within the rules and respect officials and their decisions.
- 7.0 All members must respect the rights, dignity and worth of all participants, (see Policy No. 5).
- 8.0 Members should keep to agreed timings for training and competitions or inform their coach or team manager, in advance, if they are going to be late.
- 9.0 Members must wear suitable kit – flat soled shoes, club polo shirts when appropriate – for training and match sessions, as agreed with the coach/team manager. Normally, the child will be provided with a yellow Juniors shirt to wear when attending the Junior sessions. These shirts will remain the property of the Club. Parents/Gaurdians are expected to keep the shirts in a clean condition and these must be returned to the Club when the child leaves the Junior Section.
- 10.0 Members must pay any fees for training or events promptly.

- 11.0 Junior members are not allowed to consume, or be under the influence of alcohol or drugs of any kind on the club premises or whilst representing the club.
- 12.0 Junior members may play on the green at any reasonable time. The hours of play may however be varied by the Committee. Juniors are expected to respect the play of other members, including the playing of matches or ties. They must not act in such a way as to interfere with any matches or ties.
- 13.0 Lundin Bowling Club is fully committed to safeguarding and promoting the well-being of all of its members. The Club believes that it is important that members, coaches, administrators and parents associated with the Club should at all times show respect and understanding for the safety and welfare of others.
